## CRYSTALLINE SILICA DUST HAZARD WARNING

CARRIER ACKNOWLEDGES AS FOLLOWS: (a) the silica sand (Product) to be transported by the Carrier may contain respirable crystalline silica dust, or respirable crystalline silica dust may be created during the transfer or use of the Product; (b) breathing crystalline silica dust, including, without limitation, respirable crystalline silica dust, is hazardous and can cause severe and permanent lung damage and that breathing the dust can cause silicosis, a lung disease that can cause serious breathing difficulties and death; (c) breathing crystalline silica dust may cause lung cancer, immune system effects, kidney effects and other diseases; (d) Carrier must follow OSHA and other applicable health standards (such as recommendations made by the National Institute for Occupational Safety and Health) for crystalline silica (quartz) dust. Reliant Transportation, Inc., can provide the respective product OSHA Safety Data Sheet(s) at the request of the Carrier from time to time, for more complete information on hazards and precautions. Additionally, the OSHA website contains more information on crystalline silica; the address is www.osha.gov. Carrier shall warn, protect and train its employees, agents and contractors of the hazards of improperly handling or using silica sand. Because the Product may be received, stored, resold, handled, used, packaged or otherwise employed by Carrier employees, agents and/or contractors, Carrier acknowledges that Reliant Transportation, Inc., does not have the responsibility or ability to control such circumstances or the ability in all cases to communicate warnings and other information to Carrier employees, agents, customers and contractors. Carrier agrees to and shall warn and notify its employees, agents, contractors and customers by providing them with current Shipper Safety Data Sheets as noted above, and other information issued by Reliant Transportation, Inc., or Carrier regarding warnings, product hazards and precautions to be followed in using, handling, storing, disposing and selling of sand. Carrier agrees to confirm upon written request from Reliant Transportation, Inc., that Carrier is complying with its obligations hereunder. Carrier agrees to comply with all of the terms hereof and all applicable foreign, federal, state and local laws, regulations, orders and ordinances regarding sand, exposure to crystalline silica (quartz), or Carrier operations relating to sand, including, but not limited to, the OSHA Hazard Communications Standard (29 CFR 1910,1200 et seq.), and those relating to environmental exposure, disposal, spills and cleanup, health and safety, storage, packaging, labeling, transportation and purchase of sand. Reliant Transportation, Inc., will provide copy of the OSHA Respirable Crystalline Silica Standard for General Industry and Maritime (OSHA Publication DSG FS-3682) usage at the request of the Carrier.
